Key Responsibilities

Strategic Leadership:

- Represent the organisation in national forums, media, and stakeholder engagements.

Operational Management:

- Ensure compliance with statutory and regulatory requirements.
- Lead performance management and continuous improvement across all functions.

Stakeholder Engagement:

- Build and maintain strong relationships with care providers, government bodies, local authorities, ICBs and social care representative organisations.
