Living with Covid-19: What that means for health and care staff

You will be aware that earlier this week the Prime Minister outlined the plan for Living with Covid-19 — and we know that as healthcare workers you will be wondering what that means for you, in particular relating to staff testing positive and also testing for patients and staff.

Due to the higher risk nature of health and social care settings, the advice for staff members working in these settings has not changed.

For healthcare staff who have tested positive for Covid-19 the previous rules still apply. Staff should not attend work until they have had two negative Lateral Flow Test results taken 24 hours apart. The first test should not be taken before day 5 after their initial positive test.

These tests need to be 24 hours apart, and providing staff are medically fit, they can return to work on the morning of day 6 providing they tested negative 24 hours earlier.

The UKHSA has this week updated the guidance for staff and patients exposed to Covid-19 and this has been posted on the UKHSA guidance pages here.

How your workplace can access Lateral Flow Tests

Following the Government's plan for Living with Covid-19 as mentioned above, we can confirm that current testing protocols should continue in care homes and settings until further guidance is received.

Reporting test results remains a requirement and we should encourage Adult Social Care staff to report the results of their asymptomatic tests whether positive or negative at: https://www.gov.uk/report-covid19-result. For Adult Social Care staff the requirement is that they take a daily Lateral Flow Test on the days they are working before their shift.

Below is the linked guidance which includes within a link for your workplace to sign up for your own supply of tests.

All that needs to be done is for your setting to register and receive a Unique Organisation Number (UON) at this stage. You will then be able to order every 21 days.
